Clergy Reports



Senior Pastor Kiri Solberg

e've had an extraordinary year! I give thanks to our leaders, our staff, our congregation, and to our faith in Jesus Christ who calls us into this life as a congregation together. We have had so many things to celebrate as a congregation. Looking back on 2023, here are some highlights:

Church Council

Our council is in our second year of using the strategic choices model. This model allows us to have time each meeting to focus on a different priority item, making sure that we are fulfilling our mission and vision as a congregation. Our council

has carefully and thoughtfully worked well together as a group. This year our council recommended and the congregation adopted a \$100,000 challenge budget. Our council members stepped up and committed an additional \$20,000 towards meeting that budget. They also joined the Stewardship team in writing thank you notes to givers in the congregation, giving mission moment talks during worship, and visiting some small groups to share the vision of the ministry and invite additional support.

I am particularly grateful for our executive team and their leadership. Judy Schaubach stepped into the role of council president 2 years ago having not served on council before, and brought her tremendous leadership skills to the role. Dave Anderson gives so much of his time and is completing a term as Vice President. Steve Rozek as treasurer was instrumental in getting our finance system and reports to the effective level they are now, and I am grateful to Cindy Paulson for providing her insight to this team and serving as secretary. Thank you to the executive team and to the entire council!

Staff

Our staff is strong and so committed to their roles at Our Saviour's. A highlight this year was an overnight staff retreat we held the end of January. In addition to a lot of laughs, we were very productive. We created an annual planning calendar that we reference on a monthly basis to make sure things coming up are anticipated and preparations are underway. It has been so helpful! We also worked on some relational pieces in addition to implementing several new communication ideas.

Staff transitions this year included:

- Laura Gibney stepped into the role of sound technician in Jan. after having served as a sub many times
- Jon Kosloski was hired as Facilities Manager in March
- In October two part-time roles were filled: Chelsey Klapperich started as Cemetery Administrator and Lauren Gainey started as CYF Administrative Specialist

- This year we also changed Lisa Rykken Kastler's title to Director of Congregation Ministry to better reflect the leadership she was carrying out in her role
- In September Nathan Chastek resigned as CYF Ministry Coordinator, and we re-envisioned the CYF team to include a part-time administrative Specialist and several CYF Assistants who work Wednesday evenings and Sunday mornings.
- This year we prepared for Jan Green's retirement, which will officially take place in January 2024. Jan has been a wonderful team player on our staff for over 20 years, and has grown and evolved into the effective administrator she is as the needs of the congregation have grown. We give thanks for her gifts and her thoughtful preparation to help us fill her shoes.

Stewardship

Our Stewardship team is in the second year of working with Pastor Scott Searl as our Stewardship Consultant. He has helped us shape our big-picture goals as well as walked with the Stewardship Team to plan the details of growing in our generosity as a congregation. Pastor Scott has been a valuable resource and our team has put in so much work to continue to invite people to support the ministry of Our Saviour's.

I am also thankful to Dave Eberhardt who has been chair of the Stewardship Team. He is efficient and organized in additional to having an infectious positive approach toward our giving!

What a joy it is to be leading a congregation that is making a difference in the lives of our young people and their families as well as our entire congregation! May we continue to be bold in our witness to Christ's love with our families and the greater community, as we carry out our mission to Reach Out with a Voice of Hope!

The Leadership Team for this partnership would welcome a few more members; we meet about three times a year. Our Welcoming All Neighbors (WAN) team was quite active in 2023 as well, helping our Ukrainian friends welcome another family from Ukraine. Exciting plans are underway for 2024. The North Metro Grief Support Coalition took a hiatus in 2023, prompting us to connect with our friends at Grace Lutheran Church in Andover to offer grief care. The result has been a November 2023-May 2024 Grief-

Share program offered the 1st & 3rd Thursday of each month, with facilitators from both congregations. Meetings began at Grace Lutheran, and will move to OSLC in February. Thank you to OSLC facilitators Joyce Finch, Bruce Floren, Laura Gibney, and Gloria Lien for facilitating this nationally-recognized curriculum that has been so helpful to so many as they navigate grief. GriefShare is open to people from the community as well, so share the word with friends & neighbors – all are welcome!

Our preschool continues to teach the youngest in our community under the leadership of Preschool Director Lissa Leebens. While state grants have been smaller in 2023 as Covid moves out of its pandemic phase, Lissa has kept on top of those grant opportunities and made sure we received ones we were eligible for.

We are blessed with talented and committed staff at OSLC. It is an honor to serve this congregation along-side such wonderful people as together we ponder where God might be leading as we Reach Out with a Voice of Hope.




Pop-Up Choir

In addition to the home, we gave quilts, clothing, faith beads, and toys from OSLC.

They are doing well and their home provides a solid foundation for their simple life. The relationships and connections we have made in this community are impressive and are truly making an impact on families, their faith, and the community.

Chapel, Cemetery, Columbarium

2023 marked many accomplishments for the Chapel/ Cemetery Committee. Three summer services were held and one Christmas Day service. Five graves were sold and a Cemetery Administrator was hired. In 2024, the Committee is looking forward to adding a fire alarm to the security system, continuing with foundation grant writing, and adding more events in 2024. All ideas are welcome. Cedar Creek Elementary School and OSLC/Church Partnership

Our Saviour's Lutheran Church (OLSC) has a partnership with Cedar Creek Elementary School (CCES) in East Bethel as part of an outreach to our community neighbors.

A school church partnership is an intentional relationship between a church and a school in which both parties work together for the well-being and academic success of the students. There are three pathways for churches to partner with schools:

- Supporting teachers and staff
- Providing needed goods and services
- Supporting students and families

OSLC Involvement at CCES During the 2022/23 School Year

- 1. Delivered food backpacks from the NACE Food Shelf to CCES each week.
- 2. Purchased winter coats, gloves/mittens, winter caps and snow pants for three children from one family.
- 3. Had two people work at the winter bookfair.
- 4. Provided bagels, cream cheese, and a variety of juices for CCES staff in March.
- 5. Had two people work at the STEAM night.
- 6. Had three people work at the Spring Carnival.
- 7. Provided cupcakes, cookies, and juice for the staff during Teacher Appreciation week in May.
- 8. Gifted the CCES media center \$200 dollars for the Spring book fair which enabled the school to purchase \$400 worth of books for children in need.
- 9. Had one person work at the Spring book fair. This partnership has continued in the 2023/24 school year with the same activities as above being implemented along with periodically acknowledging the Cedar Creek staff's efforts and commitment to their students on Facebook, funding a school wide assembly, and having OSLC volunteers work directly with students.

As of early December 2023, \$24,357.96 of \$25,973.88 total was disbursed leaving \$1,615.92. The remainder remains in the fund unless there is an application for funds for the remainder of 2023. If not used, the remainder will remain in the funds.

Endowment Committee

Fair Trade—Equal Exchange

The Fair Trade team continued to sell Equal Exchange products between and after services at Our Saviour's on the first Sunday of each month throughout 2023. Through this partnership with the Equal Exchange cooperative, small farmers around the world gain market access to earn a fair income. We offer a wide variety of coffee, tea, and chocolate, as well as olive oil, hot cocoa and baking cocoa.

In order to raise awareness about our mission, in October we hosted Hospitality and raffled off gift baskets of Fair Trade products. We are hopeful that the family of Our Saviour's will continue to support subsistence farmers through this mission.

Family Promise

Family Promise in Anoka County serves families who are experiencing homelessness. While the primary reason for their homelessness varies from family to family, one thing is true about all our guest families—they desperately want to achieve housing stability. Through their own hard work, guided by our case management and other programs, we help them achieve that dream!

Families can stay in the program for up to 90 days. During that time, they receive support and advocacy through case management to find a permanent, stable home. After exiting the program, they can take advantage of ongoing supportive services to help maintain stability.

We currently have a capacity limit of four families or 14 individuals. Families vary in size and acceptance into the program can be challenging for larger families.

Glen Cary and Our Saviour's co-coordinate as Host Sites of the program. The Host Site Coordinator oversees the needs of each family enrolled during the Host Week. We are scheduled to serve 4 to 5 weeks a year.

Family Promise is transitioning to a site location where the families will stay until exiting. This change will take place sometime during this year. Volunteering consists of helping with meals, and donations of \$35 gas cards.

Hard Hat Ministry

The Hard Hats are believed to be the longest standing group ministry at OSLC. We have continued to meet every Wednesday from 8:00 a.m. to 12:00 noon for coffee, devotions, fellowship, and general maintenance tasks for

the church since 2000. The group welcomes people of all ages to enjoy fellowship and service. Over the years, the Hard Hat group has grown from our eight original members to over thirty-five active members today.

Our members bring an ever-expanding variety of skills and knowledge which has enabled the Hard Hats to accept challenging tasks. As our ages continue to climb, we look for younger blood to work on those "higher" projects. The group's main focus over the years has been working on the OSLC properties. We have also responded to needs within our community where the project is considered within our skill sets.

Highlights of a couple projects from this past year: the Hard Hats finished laying pavers connecting the columbarium with the Meditation Garden pathway and south parking lot. They landscaped this area by hauling in black dirt and sodding/seeding the area and they also installed a fountain in the columbarium area.

In the spring of 2023, the Hard Hats debated if we would be able to continue maintaining the OSLC grounds as we have since we moved into our Jackson Street facility in 2004. We previously had two of our members bringing their industrial size mowers each week and spending four or more hours mowing on Wednesday morning through the grass-growing season. In the spring of 2023, we learned the services of the volunteers and their mowers were not going to be available as in the past. This left us with a lawn maintenance problem. We contacted two lawn maintenance companies for bids and found the cost for mowing and weed whipping the Jackson Street property weekly during the grass growing season would cost the church in excess of \$20,000. Lawn care has never been an item in our church budget because it was assumed the Hard Hats would handle it. The Hard Hats agreed to purchase an industrial size used mower with our funds and train volunteers on how to operate this mower. Our concern is how long we will be able to continue maintaining the church grounds without either having to contract it out or having non-Hard Hat volunteers take on this responsibility.

All the funds the Hard Hats receive each year from memorials, contributions and sales of pop and crafts are spent on church maintenance projects. Projects assumed and funded by the Hard Hats during 2023 were:

- Repairing and expanding the irrigation system
- Maintaining the fountain in the Meditation Garden
- Installing the fountain in the Columbarium area
- Pruning, replacing and removing dead and dying trees
- Maintaining the church grounds by mowing and weed whipping
- Doing spring cleanup at the Chapel

- Repairing and replacing of lights inside and outside the church
- Installing tile at the south and east entrances in preparation for the new carpet
- Cutting down and removing several dead pine trees at the Chapel
- Installing and taking down outdoor Christmas lights
- Helping with the confirmation youth event at the Chapel
- Assisting with event setups
- Putting up and taking down snow fence.
- Landscaping, fertilizing and seeding the areas around the church
- Replacing some evergreen trees in the Guardian Grove
- Completing a pathway of pavers connecting Columbarium with the Meditation Garden
- Painting the light pole bases and curbing
- Spraying for weeds around the church lawn
- Cleaning and maintaining the air handlers on the roof of the church
- Patching potholes and filling cracks in the driveway and parking lots
- Installing new heat-tapes on the roof
- Repairing the church pews
- Moving office furniture during reorganization of offices
- Repairing storm-damaged metal flashing on the church roof
- Repairing and maintaining snowblowers, mowers, and weed whips
- Hauling 55 cubic yards of mulch and spreading it in the gardens and the islands in the parking lot area
- Repairing, replacing and maintaining the bluebird houses on the church property
- Sealing corners and seams on the church roof
- Spackling and painting room 118
- Setting up, moving and taking down the risers as needed
- Watering the new trees on a weekly basis
- Shoveling and clearing snow/ice from the church sidewalks
- Filling in where needed until a new Facilities Manager was hired.

This list does not cover all the things the Hard Hats have done over the past year, but it is representative of the things we do for the church and for our community. We thank the congregation for supporting the Hard Hats throughout the year. Without your gifts we would not be able to continue providing additional maintenance and "wished-for extras" for the church.

Property Team

The Property Team consists of the OSLC Facilities Manager, a church council representative, and five members of the congregation. The Property Team surveys the needs of the OSLC Jackson Street facilities and makes recommendations to the OSLC Council concerning capital improvements and repairs. These needs are prioritized and submitted to OSLC Council with estimated costs.

During the past year the Property Team collected bids for projects, made recommendations to OSLC Council, and monitored the projects to their completion. The projects for 2023 consisted of requesting bids and contracting for the replacement of the third HVAC unit, requesting bids and contracting the installation of a temperature control system for the pipe organ pipe room, requesting bids for the repair of storm damage at the Jackson Street facility and the Chapel, and requesting cost estimates for sealing the south parking lot and removal/replacement of the asphalt in the north parking lot. The property team also provides information to the OSLC finance team for the annual budget by collecting cost estimates for annual maintenance and for anticipated capital improvements/ repairs at the Jackson Street facility.

The Property Team will be conducting a survey of needed capital improvements and repairs in early 2024 and will submit findings and recommendations to the new 2024 OSLC Council.

Treasurer's Report

2023 Summary

We started this year with a Challenge Budget of \$100,000 over and above the predicted giving knowing what a generous and giving congregation Our Saviour's is. The commitment to staffing our Children, Youth and Families as well as the Music and Worship teams was overwhelming as the contributions came in throughout the year and especially in December as evident by the almost \$14,000 net surplus at the end of the year. It is clear that the congregation fully supports the programs which allows us to truly reach out with a voice of hope!

Items of Note During 2023

Economically, interest rates

surged upward in our country. Our bookkeeper Beth noted that it would be worth checking into earning more interest on the roughly \$500,000 in our savings accounts. We worked with our bank to move our savings accounts to market rate interest rates which ended up bringing in over \$15,000 for the year.

The government has a program called the Employee Retention Act that rewards businesses and nonprofits for keeping people employed. This program offers a refund for some payroll taxes that have already been paid out. We filed for this refund and are still awaiting hearing back from the IRS, but hope to have our application accepted which would then result in receiving a significant refund check in 2024.

We utilized funds carried forward from the Points Forward Program from last year for a mini-split HVAC unit that was installed in the pipe organ room to regulate temperatures to avoid unnecessary repairs to that beautiful instrument. We also ordered a replacement for the third RTU that sits on the roof and provides both heating and air conditioning for our building.

Finance Team

It has been a privilege for me to serve as Council Treasurer of Our Saviour's.

I would like to acknowledge the Finance Team members for their thoughtful advice and uncompromising support throughout the entire year: Dave Anderson, Kim Anderson, Jason Moehring, and Kari Wolff. Their willingness to serve, attend meetings, and share ideas has been very helpful as we planned for a viable path forward.

Working with Beth Graham, our bookkeeper, has been a very positive experience! In addition to the weekly check generation, monthly reconciling, and generally keeping me informed on all things financial at Our Saviour's, she is exceptionally skilled at using the Shelby electronic accounting system pushing the limits of what it can do and extending Our Saviour's utility by implementing a Purchasing Management component. This uses scanned and electronic receipts that makes expense reporting so much easier for each staff member and enables Beth to be very accurate and timely in sharing information.

A sincere thank you to Pastor Kiri for her meaningful participation, extensive and well-developed ideas and for her guidance offered to me and the Finance Team. She is always a positive influence as she stays actively involved and informed.

In closing, I want to thank the Council for their patience in reviewing my technical reports as I was learning the ropes of being Treasurer. Thank you to the congregation for their unending generosity and for contributing to the mission of Our Saviour's enabling us to unwaveringly reach out with a voice of hope as we share our faith productively with all of our members and many people in our community.

May we rejoice in all of God's blessings!

Other events this year that have helped decrease expenses were refinancing the mortgage, grants given to the Preschool Program and decreased personnel costs due to the lack of a full staff.

In 2023 OSLC began utilizing the existing Shelby System for purchasing management of invoice/payments, approvals, and processing. This has resulted in many efficiencies, improved communication, and improved budget management. Receipts and invoices can now be digital files, are submitted faster, and approvals happen more efficiently. Information can now be stored in a secure digital file in the Cloud that is consistently backed-up and secure.

The Audit Committee reviewed income and expenses for the General Fund, bank statements; balanced year-end bank statements for the Reserve Fund, Endowment Fund, Property Maintenance account, General Fund Statement, Dedicated Fund accounts, and reviewed the Cemetery Fund investment balances. The committee reviewed processes, standards, and security.

The Audit Committee performed the following tasks:

- Checked the procedure for handling income and donations to ensure standards and policies are followed.


